Annual Count ~ N or D

- **Used to allocate FY 2016-17 funds**
- **Based on 2015-16 enrollment**
 - Eligibility requirements
- **Template with built-in validation**
 - Local institutions (Subpart 2)
 - Neglected (Part A) and Delinquent (Part D)

Local Institutions ~ Eligibility

- **Children must meet ALL criteria:**
 - Live in local institution for neglected or delinquent children
 - Are age 5-17, inclusive
 - Live in the residential program for at least one day during a count period of 30 consecutive days
 - At least one day in October 2015

- Make sure the Facility Name is included in the file name





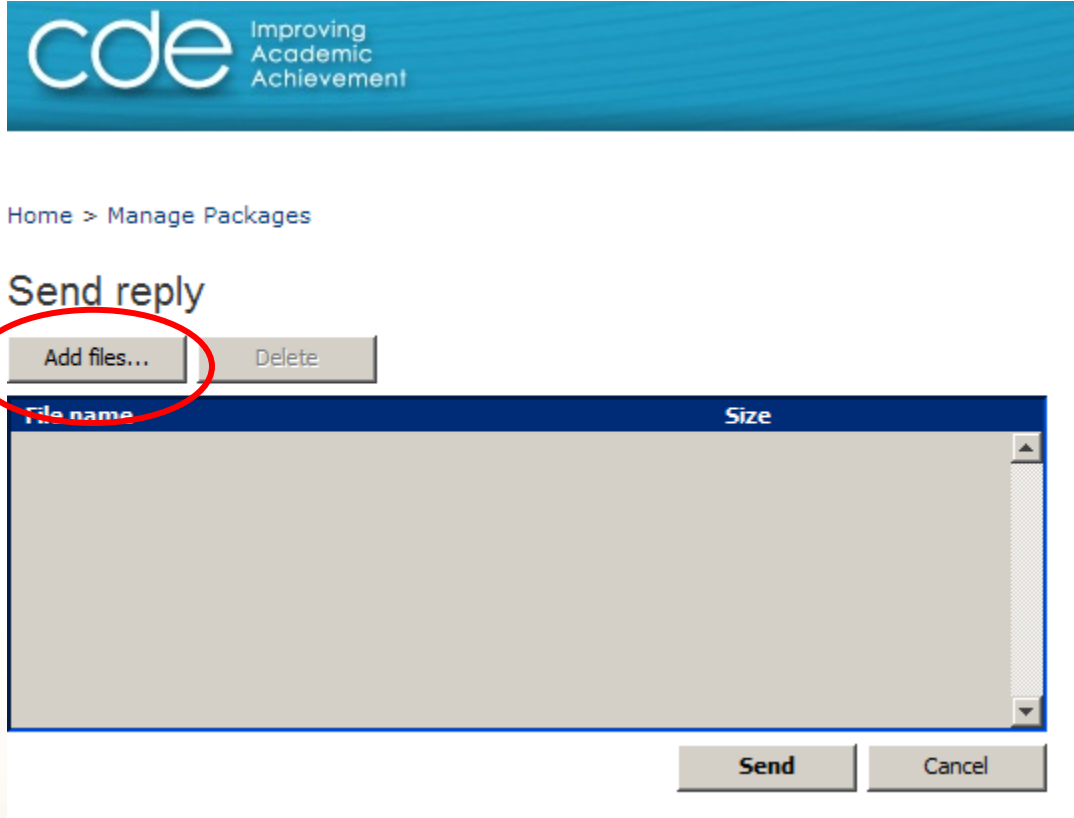
