MEANINGFUL FAMILY AND COMMUNITY ENGAGEMENT: SYSTEM INVOLVEMENT TUESDAY, MARCH 18, 2014

The involvement of family members, caregivers, and other caring adults is critical in the lives of youth who are neglected, delinquent, or at risk. But often times schools, facilities and programs struggle to actively engage these individuals. The "Meaningful Family and Community Engagement" topical call series explores ways of fostering, increasing, and sustaining meaningful engagement of the important adults in the lives of N or D youth, from the time a youth enters the justice system through his or her return to the community. This series addresses culturally relevant outreach, preparation and training for family members and caregivers, the importance of community and natural supports, and much more.

This document provides a summary of the second topical call in this series. It discusses:

- The importance of maintaining engagement of family members and caregivers once a youth is system involved.
- Examples of ways in which systems, facilities, and programs can actively engage families and caregivers.

OVERVIEW

During this call, Ms. Grace Bauer, Executive Director, Justice for Families and Dr. Ryan Shanahan, Sr. Program Associate, Family Justice Program, VERA Institute of Justice, discussed the importance of continuing family/caregiver engagement once a youth has entered a juvenile justice facility or program. Ms. Bauer shared her perspective from both her professional role with Justice for Families as her personal encounter as a mother of children who experienced system involvement. Dr. Shanahan shard the findings of research conducted by the VERA Institute for Justice that underscores the importance of encouraging continued family/caregiver engagement once youth are system involved. Both presenters provided examples of activities programs and facilities can undertake to encourage family/caregiver engagement. A synopsis of the role of State TIPD coordinators in family/community engagement concluded the presentation.

TOOLS, TIPS AND TAKE-AWAYS

For Family Members and Caregivers

- Family/caregivers should share all relevant or missing information about their child with the facility or program to ensure the child's needs are met.
- Families and caregivers are vital participants in treatment and follow-up care.

For Systems, Facilities, and Programs

- Systems, facilities, and programs must work diligently to overcome barriers and challenges to family/caregiver engagement.
- Due to the inherent distrust between families and systems, it is essential that families who
 are new to the juvenile justice system connect with experienced families that can help them
 navigate the system.
- There is a continuum of family involvement and system changes do not have to occur all at once.
- Many States have best practices, e.g., a Parents' Bill of Rights, which can be replicated.

For State TIPD Coordinators

- Encourage subgrantees to include family/caretaker engagement as a part of their TIPD applications, which is consistent with Section I in the Nonregulatory Guidance.
- Include family/caregiver engagement as part of your monitoring plan.
- To the extent feasible, support use of TIPD funds to encourage family/caregiver engagement in programs and facilities.
